Repeaters Fee:

After paying the examination fee student should submit the fee paid receipt to the law office to update the KSLU application form.

Payment of examination Fee is <u>not a guarantee that the student will be allowed to write the examination</u>. A student will be allowed to write the examination only if:

- ➤ The acceptance and registration of applications for the examination is provisional. Admission to examination is subject to students fulfilling all eligibility criteria (KSLU & college) to write examination, including eligibility for admission approval and promotion.
- > Student should have the required minimum attendance for each course at the end of the semester
- ➤ Principal / Management should be satisfied with the general behavior of the student.
- > It is to be noted that remitting fees and submitting Examination Application is mandatory for students seeking Admission to next Academic Year.
